## **Background and General Overview:**

Our organization started and continued as a volunteer-based organization until just a couple of years ago when the Board of Directors decided to take a big step and bring in some paid support to help. This has led to where we are today—still a primarily volunteer-board-run affiliate but with now four paid part-time contractors to help take us to the next level.

All services are focused on meeting the ever-changing needs of our Bay Area residents who have an individual with autism in their family or who are providing services for an individual with autism. We provide activities that are safe and secure for the entire family throughout the Bay Area typically at a nominal cost. We offer vital resources for all types of referrals through our Information and Resource Line. Lastly, we have a worldrenowned annual Autism Conference that is attended by hundreds of family members and service professionals each year at Stanford University.

We are looking to expand our impact over 2024 and beyond. We would like to spread our activities more evenly throughout the greater Bay Area. We are also looking at how to address other important needs or gaps in services that our families are experiencing. To that effect our Board of Directors along with our staff is now tackling critical infrastructure voids, and we will be moving forward with some basic strategic thinking about any bigger issues that we feel we could contribute toward resolving for the community that we so love.



## SFASA as part of Autism Society National:

We are one of the largest of the 70 state and local affiliates of Autism Society National. We have a loose affiliate agreement, which allows us to benefit from the name recognition of such a large grassroots organization while remaining free to conduct our affiliate activities as we see fit for our local community. National offers us many resources that we can utilize for advocacy, fundraising, etc. They are currently trying hard to meet the individual needs of their many affiliates, but of course, it is a work in progress.
